The Compliance Office is currently updating its DCBO selection process. At the workshop we will discuss the goals and

objectives of the new process, outline the updated DCBO approval and selection procedures, provide an overview of the contracting materials included with each draft RFQ template and discuss the anticipated RFQ processing and DCBO deployment timelines.
