**THE LOS ANGELES DEPARTMENT OF WATER AND POWER’S REQUEST FOR  
CORRECTION TO TRANSCRIPT OF DECEMBER 15, 2016 COMMITTEE STATUS  
CONFERENCE (TN 215130)**

On December 30, 2016, the Committee posted a Transcript of the December 15, 2016 Committee Status Conference in 16-RPS-02, TN 215130, (“CSC Transcript”). LADWP requests that corrections be made to the CSC Transcript as described below in accordance with the Committee’s General Orders Regarding Electronic Document Formats, Electronic Filing and Service of Documents and Other Matters, TN 212640, (“General Order”).

1. Request for Corrections to CSC Transcript Pursuant to General Order.

The General Order states that the parties “are responsible for identifying errors in the transcript of the proceedings. Proposed corrections to the transcripts must be filed within 30 days of the filing of the transcript.” General Order at pg. 5 (Transcripts). As noted above, the Committee filed the Transcript on December 30, 2016.

LADWP requests that corrections be made to the statements of Deputy City Attorney Jean-Claude Bertet contained in the following portions of the CSC Transcript:

- Transcript at 10:4 – the word “in” should be added to the end of line 4. The proposed corrected quote contained on Transcript 10:4-7 should read as follows:

“Just to make sure we’re clear, too, in that basically by directing you to respond to these specific questions, that we will allow you to present your full case.”

- Transcript at 10:12-14 – the quotation marks should be deleted. The proposed corrected phrase contained on Transcript 10:13-14 should read as follows: “you will get your opportunity to present your full case.”

- Transcript at 10:16-18 – the quotation marks should be deleted. The proposed corrected phrase contained on Transcript 10:16-18 should read as follows: “ the Committee was going to determine whether evidentiary hearings would be required and that any additional information would be required.”
