

Re: Repeated Application for Confidential Designation Pursuant to Section 2505(a)(4) of Title 20: SMUD's Cosumnes Power Plant (01-AFC-019C): Cultural Resources

Dear Ms. Jones:

Pursuant to Title 20 of the California Code of Regulations and direction received from CEC staff, the Sacramento Municipal Utilities District (SMUD) hereby submits this "Repeated Application for Confidential Designation Pursuant to Section 2505(a)(4) of Title 20: Cosumnes Power Plant (01-AFC-019C): Cultural Resources."

Section 2505(a)(4) provides that if an applicant's prior application for confidential designation of substantially similar information has been granted pursuant to Section 2505, a subsequent application need only contain certification pursuant to Section 2505(a)(1)(G) that the information submitted is substantially similar to the initial application and that all facts and circumstances relevant to the granting or approval of the initial application are unchanged.



Pursuant to direction received from CEC staff, SMUD now wishes to submit this repeated application for confidential designation for the following document:
