Notification of CBO Delegate Designation**

Dear Ms. Juarez-Garcia,

The Sacramento Municipal Utility District's January 2002 Memorandum of Understanding with the California Energy Commission delegates Chief Building Official duties to SMUD for the Cosumnes Power Plant and Gas Pipeline extension. The MOU is attached for your reference. Paragraph 6 of the MOU states that the CPM shall have the right to approve the qualifications of the CBO engineering and technical personnel. Additionally, Paragraph 7 authorizes SMUD to retain the services of independent qualified subcontractors to supplement its own employees in design review, plan check, and construction inspection.

Although plant construction is complete and it has been in commercial operation since February 24, 2006, SMUD desires to retain qualified CBO staff to maintain its MOU commitment should any immediate need arise that requires CBO review. In addition to those individuals already approved by the CEC (namely, Chuck Sinkey, S.E., Structural Engineering, and Al D'Heurle, P.E., Mechanical and Controls Engineering), SMUD proposes the following individuals for CBO-delegate duties should the need arise. The updated credentials of all these individuals are attached to this letter.

- Oai Lam, P.E. Electrical Engineering
- Chan Lam, P.E. Mechanical and Process Engineering
- Eric Quintero, P.E. Mechanical Engineering

In accordance with SMUD's September 14, 2007 letter to Ms. Paula David, the Chief Building Official for SMUD is still Mr. Scott Flake, P.E. We look forward to the CEC's written approval
