**(SECOND) REVISED COMMITTEE SCHEDULING ORDER**


On November 17, 2006, the Petition to Amend the Commission Decision was filed with the Energy Commission. The Petition will be processed as provided in Title 20, California Code of Regulations, section 1769. The Committee conducted a public informational hearing on December 15, 2006, to discuss the schedule and other issues of concern and issued a Scheduling Order on December 21, 2006. A revised Scheduling Order was then issued on March 21, 2007.

At the Status Conference on June 6, 2007, the parties stipulated to further revisions in the schedule. That schedule would have the Staff's final analysis published on June 29, 2007. A fourteen day public and agency comment period would end on July 13, 2007. During the week of July 16, 2007, a Prehearing Conference and, if the matter is ready for hearing, an Evidentiary Hearing would be held.

A revised Committee Schedule, consistent with the above stipulation, is attached. The schedule covers the period leading up to a Prehearing Conference and Evidentiary Hearing on July 19, 2007. The balance of the schedule, including whether it is appropriate to hold the Evidentiary Hearing on July 19, will be determined at the Prehearing Conference.

We may further modify the schedule at any time upon either our own motion or that of a party. [Cal. Code Regs., tit. 20, § 1709(c)].
