I make this Public Records Act Request in accordance with the requirements of Section 6253 of the Government Code, for copies of information and documents for the following facility: Russell City Energy Center Amendment No. 1 (01-AFC-7C), Final Commission Decision, Docket Date Oct 02, 2007, to be produced in ten days, by or before Monday, January 19, 2009.

**1. Re: Page 29 Monthly Compliance Reports (Compliance -6)**

The first Monthly Compliance Report is due one month following the Energy Commission business meeting date upon which the project was approved, unless otherwise agreed to by the CPM.

If in the event no monthly reports have been filed then your response should state that your agency has no such records or identify the months missing.

**2. Re: Page 31 Annual Energy Facility Compliance Fee (Compliance -9)**

Pursuant to the provisions of Section 25806(b) of the Public Resource Code, the project owner is required to pay an annual fee currently seventeen thousand six hundred seventy six dollars (\$17,676) which will be adjusted annually on July 1. The initial payment is due on the date the Energy Commission adopts the final decision.

I request either copies of the checks or a declaration confirming that all fees have been paid to date.

Accordingly, I request a waiver of any associated fees to comply with this request. However, if you refuse to waive such fees, please email me at [andy\\_psi@sbcglobal.net](mailto:andy_psi@sbcglobal.net) by Monday, January 12, 2009, to provide me an estimate of any costs involved to obtain these documents within the statutory time period.

Additionally, if any part of this request is denied, please provide your written determination on the basis of the denial, as required by section 6255(b) of the California Government Code.
