II. DISCUSSION


Section 1720.2 of our regulations [20 Cal. Code of Regs., §1720.2] provides that a Committee may terminate a proceeding based upon an Applicant's failure to pursue the application or notice with due diligence. We find that the considerable period of inactivity in this case falls within this provision, and agree that no useful purpose would be served by continuing the period of suspension.

We therefore affirm and adopt the Committee ORDER.

III. ORDER


