Upon consideration of the Petition to Intervene filed by Floyd P. Wolfe, the Committee designated to conduct proceedings in this matter makes the following findings:


1. On June 29, 2005, a Petition to Intervene in the above-captioned proceeding was filed by:


2. The Petition was timely filed and contains the information required by section 1207 of the Commission's regulations (Cal. Code of Regs., tit. 20, § 1207);
