I. BACKGROUND

On June 27, 2005, the Committee issued an Order directing that Intervenor Greenaction for Health and Environmental Justice (Greenaction) respond to data requests from Intervenor Californians for Renewable Energy (CARE). Greenaction complied with this Order on June 29, 2005. Because it was apparently unaware of CARE's data request, however, Greenaction asks that we require CARE to "...provide hard copies of all requests, motions, and responses in this proceeding to all intervenors and interested parties, and have them delivered via U.S. Postal Service." (Greenaction's Protest of Motion to Compel, p. 1.)

II. DISCUSSION

We granted CARE's intervention with hardship status on July 9, 2004. As part of being granted hardship status, CARE is entitled to "...e-mail its filings to those on the Proof of Service list with e-mail addresses indicated...". Greenaction's e-mail address appears on the Proof of Service.


Additionally, the Office of the Public Advisor has informed us that it mailed paper copies of relevant CARE documents to the other parties. It therefore appears no irregularities in service occurred and that there is insufficient reason to alter existing procedures.

III. ORDER

Documents shall continue to be distributed according to practices specified in sections 1209 -1210 of Commission regulations [20 Cal. Code of Regs. Sections 1209, 1209.5, 1210] and Committee Orders. The Office of the Public Advisor shall continue to serve upon the other parties paper copies of documents filed by Intervenor with hardship status.




