Intervenor VISION OF POWER, a group of concerned citizens in and around the City of Carlsbad, hereby states their strong support of Intervenor Center for Biological Diversity’s November 10, 2008 motion to compel responses to its data requests. We agree with the importance of the Center’s concern about GHG emissions, as stated in their September 26<sup>th</sup> data requests.

We are further concerned by the applicant’s objections based on timeliness, since they themselves have filed major amendments to the AFC well after the supposed 180-day period for data requests, and since we are currently in the process of preparing our own data requests.

Recognizing that there are still many issues for the applicant and staff to resolve, we do not believe that an order from the Commission compelling the applicant to respond to the Center’s data requests will delay the project, nor do we believe that the applicant’s November 20, 2008 Response to Center for Biological Diversity’s Petition for Order Directing Response to Data Requests answers questions that are of utmost concern to the public.

POWER OF VISION urges the Commission to grant the Center’s motion to compel the applicant to fully answer the Center’s data requests, preferably in writing, so that such answers can be analyzed before any public hearings are held .
