Dear Presiding Commissioner Boyd and Commissioner Eggert:

It is our understanding that siting committees have, in the past, solicited comments and conducted hearings on an issued Presiding Members' Proposed Decision. The City of Carlsbad, as an active intervener and a representative of the people of this community, respectfully requests that any such scheduled hearing be held locally, here in Carlsbad. The reasons behind this request are as follows:

- (1) Public interest in the proposed project is very high. This Committee will recall the significant public opinion offered at the various public meetings held in this community.
- (2) There are a number of local organizations, in addition to the City, that have a deep interest in the disposition of this application. These organizations include the South Carlsbad Coastal Redevelopment Agency, Terramar Association and Power of Vision



(3) The contested issues involve areas of deep concern to the citizens of the City. Your Committee will be determining consistency with the City's land use regulations, its redevelopment agency, visual impacts on its citizens and fire safety for its workers.

For these reasons we respectfully request that you consider holding any scheduled PMPD hearing in the City of Carlsbad. The City will fully cooperate in obtaining meeting room space and any other logistical requirements that the Committee may have.
