Subject: **COMMUNITY POWER PROJECT (07-AFC-7) STATUS REPORT #9**

Pursuant to direction from the Hearing Officer, dated June 23, 2008, the following is the Energy Commission staff’s Status Report #9 for the proposed Kings River Conservation District Community Power Project (CPP).

Staff has been working through the analysis phase of the Application for Certification (AFC) process for the proposed CPP.

1. An Issue Resolution Workshop had been scheduled for January 8, 2009. At the request of the applicant, the workshop has been postponed. The applicant understands that the PSA cannot be published until the outstanding issues related to Cultural Resources and Soils and Water are resolved.
2. The San Joaquin Air Pollution Control District has still not issued their Preliminary Determination of Compliance (PDOC). The PDOC is expected January 2009.

Schedule

A specific timeline will be recommended after the issues related to Cultural Resources and Soils and Water are resolved.
