

Purpose

The purpose of this teleconference workshop is to facilitate laying the final ground work for conducting the Wildlife Corridor Study in the Carrizo Plains in coordination with the CESF applicant, applicants for Optisolar's proposed Topaz Solar Farm and SunPower's proposed California Valley Solar Ranch, the public, interveners in the CESF proceeding, and local, state and federal agencies. The agenda for the teleconference workshop is as follows:

1. To receive comments and answer questions on the draft scope of work for the study which will be undertaken by the Energy Commission's consultant for wildlife corridor modeling, South Coast Wildlands. The draft scope of work will be posted on the Energy Commission's website during the week of December 29, 2008;
2. To provide an overview of the study methodology and process;
3. To facilitate the exchange of data between parties; and
4. To obtain or identify resources to rank criteria for the modeled input of the focal species consisting of San Joaquin kit fox, tule elk and pronghorn.

Comments received during the teleconference workshop will be used to guide the study. Written comments are welcome and may be submitted in writing during the course of the study to John Kessler, Project Manager, at the address on this letterhead or by email to jkessler@energy.state.ca.us.

Background

On October 25, 2007, Carrizo Energy, LLC submitted an AFC to the California Energy Commission to develop a nominal 177 megawatt (MW) net solar thermal power plant in eastern San Luis Obispo County, California. The 640-acre proposed project site is located immediately adjacent to California State Route 58 (SR-58/Carrisa Highway),

approximately three miles west of Simmler. On December 19, 2007, the Energy Commission accepted the AFC as complete which initiated the Energy Commission staff's independent review of the proposed project. On July 3, 2008, the applicant filed a Supplement to the AFC describing changes to the proposed project. The primary changes consist of proposing that the solar reflectors be aligned in a north-south rather than an east-west direction, rotating and relocating the power block slightly east of the original location along the northern site boundary, reducing the length of the two air-cooled condensers, performing on-site manufacturing of solar collectors, and reducing the number of steam drums from twenty to eight in the solar field and from two to none in the power block. The Energy Commission is responsible for reviewing and deciding whether to approve applications for construction and operation of thermal power plants in California with a capacity of 50 MW or greater.

On November 21, 2008, Energy Commission staff published the Preliminary Staff Assessment containing staff's initial engineering and environmental evaluation of the CESF project. Among the technical areas for which staff is still evaluating mitigation measures to reduce the CESF's potential adverse impacts to less than significant, is Biological Resources. Energy Commission staff, is working with the California Department of Fish and Game (CDFG), U.S. Fish and Wildlife Service (USFWS), San Luis Obispo County (county), and the CESF applicant to assess habitat quality and connectivity issues in the Carrizo Plains. Staff intends to use the results of the Wildlife Corridor Study to develop a suite of mitigation measures that would mitigate the CESF project's direct and cumulative contributions to Biological Resource impacts to less than significant, which would then become recommendations in the Final Staff Assessment.


