

I eliminated several other sources for being VOC only, however, I did bring back one source (a bag house) that you eliminated for lack of sufficient data to perform modeling. We can discuss it, but I think that you can use the other bag house identified in the list to fill in the missing data. We have done that sort of thing in prior cases for cumulative assessments.

Hi Joseph,

Please see the attached CPP-cumulative source excel spreadsheet that was originally sent from Chris Perry in SCAQMD. After doing our best to get information from SCAQMD permit engineers or directly from the permit applicants, you can see on the first tab of the spreadsheet that we have already eliminated some of the sources (R and S columns). The sources we eliminated because they are outside 6 miles, VOC sources, tanks, or other reasons. For the ones showing "x" or "?" in R column, we either assume they will be "probably" included in the cumulative analysis or don't

have any further information. Some of these sources you can find the detail information in the other tabs in the same excel spreadsheet. We also have a CD we requested from SCAQMD. This CD also has some of these permits information. If you need the data in the CD, we can either ship it to you or put the CD files on ftp site for you to download.
