Your name was provided to the California Energy Commission by the Native American Heritage Commission as a representative of a Native American community who might be interested in the proposed construction and operation of a natural-gas-fired power plant in northeastern Anaheim, in Orange County (see attached map).

The Energy Commission has jurisdiction over the proposed project and has received an application for a permit to build and operate the power plant, known as the Canyon Power Plant. 




