Rice Solar Energy, LLC, (RSE, LLC) is the owner of the Rice Solar Energy Project (RSEP). RSE, LLC, requests that the attached information be designated confidential pursuant to 20 CCR Section 2505. The following information is being supplied to the California Energy Commission (CEC) in response to Staff Data Requests.

On October 22, 2009, the Applicant filed an original request for Confidentiality for Cultural Resource Information as part of its original Application for Certification (AFC). The Executive Director granted Confidentiality for the original submittal on November 30, 2009. This additional information is substantially similar and related to the original request.
