Contra Contra Generating Station LLC (CCGS LLC) is the owner of the Oakley Generating Station (OGS), formerly known as the Contra Costa Generating Station (CCGS). CCGS LLC, requests that the attached information be designated confidential pursuant to a Repeated Application for Confidential Designation under Title 20, Division 2, Chapter 7, Article 2, Section 2505(a)(4) of the California Code of Regulations (CCRs). This information is being supplied to the California Energy Commission (CEC) as an attachment to Supplemental Information Item #3 for the Oakley Generating Station.

In support of its application for confidential designation, CCGS LLC provides the following information:

"[a]n applicant... seeking a confidential designation for information that is substantially similar to information... for which an application for confidential designation was granted by the Executive Director pursuant to subdivision (a)(3)(A) of this section, the new application need contain only a certification, executed under penalty of perjury, stating that the information submitted is substantially similar to the previously submitted information and that all the facts and circumstances relevant to confidentiality remain unchanged."
